NOTICE OF NON-JUDICIAL FORECLOSURE SALE

WHEREAS, on November 8, 2006, Elio Fontanez, executed a Deed of Trust to secure in the payment of that certain Promissory Note of even date therewith in the principal sum of **\$27,000.00 (Twenty Seven Thousand and 00/100s Dollars)**, said Deed of Trust being filed for record as document #13275 of the Hill County Clerks Records. Subsequently an Assignment of Notes and Liens dated October 31, 2019 in favor of ACTT Properties, LLC, a Delaware limited liability company to which and the record thereof reference is made for all purposes. By Real Estate Mortgage to Secure Assumption, Dated November 26, 2008 and recorded in Hill County Clerk's Records as Document # 00024800 in Vol. 1505, Page 270 the above referenced Promissory Note was assumed by Eutalio Abreu.


The property to be sold is the same property described in said Deed of Trust, except as same may have been modified of record.
