Notice of Foreclosure Sale

1. *Property to Be Sold.* The property to be sold is described as follows:

All of that certain piece or parcel of land situated in and being in the town of Mt. Calm, Hill County, Texas, said piece or parcel of land being more fully described as follows: Being Lots One (1) and Two (2) and Three (3), in Block No. Eight (8), of said town as shown on a map of the City of Mt. Calm, Hill County, Texas, recorded in the Deed Records of Hill County, Texas, at Hillsboro, Texas. Such plat is recorded in Volume 19, Page 36, of the Deed Records of Hill County, Texas, Hillsboro, Texas, and being part of the property described in a deed from John A. Blackburn and wife, Eunice Nolen Blackburn, to Dolph J. Blackburn dated March 6, 1971, and recorded in Volume 505, Page 892 of the Hill County Deed Records, and being the same property conveyed in a deed from Olin Leathers and wife, Donna Leathers, to Robert E. Leathers and wife, Catherine Leathers by deed dated August 17, 1987, recorded in Volume 688, Page 715, Hill County, Texas Deed Records, and in a deed from Robert E. Leathers and Catherine Leathers to Olin Leathers, dated May 16, 1988, recorded in V.699, Page 118, Deed Records of Hill County, Texas.

2. *Instrument to be Foreclosed.* The instrument to be foreclosed is the deed of trust recorded in Volume 1752, Page 610 of the real property records of Hill County, Texas.

3. *Date, Time, and Place of Sale.* The sale is scheduled to be held at the following date, time, and place:

Date: October 1, 2013

Time: The sale will begin no earlier than 10:00 a.m. or no later than three hours thereafter. The sale will be completed by no later than 4:00 p.m.

Place: 80 Waco Street, Hillsboro, Texas, at the following location: East side of the Hill County Courthouse.

The deed of trust permits the beneficiary to postpone, withdraw, or reschedule the sale for another day. In that case, the trustee or substitute trustee under the deed of trust need not appear at the date, time, and place of a scheduled sale to announce the postponement, withdrawal, or rescheduling. Notice of the date of any rescheduled foreclosure sale will be reposted and refiled in accordance with the posting and filing requirements of the Texas Property Code. The reposting or refiled may be after the date originally scheduled for this sale.

4. *Terms of Sale.* The sale will be conducted as a public auction to the highest bidder for cash, subject to the provisions of the deed of trust permitting the beneficiary thereunder to have the bid credited to the note up to the amount of the unpaid debt secured by the deed of trust at the time of sale.

Those desiring to purchase the property will need to demonstrate their ability to pay their bid immediately in cash if their bid is accepted.

The sale will be made expressly subject to any title matters set forth in the deed of trust, but prospective bidders are reminded that by law the sale will necessarily be made subject to all prior matters of record affecting the property, if any, to the extent that they remain in force and effect and have not been subordinated to the deed of trust. The sale shall not cover any part of the property that has been released of public record from the lien of the deed of trust. Prospective bidders are strongly urged to examine the applicable property records to determine the nature and extent of such matters, if any.

Pursuant to the deed of trust, the beneficiary has the right to direct the Trustee to sell the property in one or more parcels and/or to sell all or only part of the property.

Pursuant to section 51.009 of the Texas Property Code, the property will be sold in "as is, where is" condition, without any express or implied warranties, except as to the warranties of title (if any) provided for under the deed of trust. Prospective bidders are advised to conduct an independent investigation of the nature and physical condition of the property.

Pursuant to section 51.0075 of the Texas Property Code, the trustee reserves the right to set further reasonable conditions for conducting the sale. Any such further conditions shall be announced before bidding is opened for the first sale of the day held by the trustee or any substitute trustee.

5. *Type of Sale.* The sale is a nonjudicial deed-of-trust lien foreclosure sale being conducted pursuant to the power of sale granted by the deed of trust executed by Billy Ray Leathers and All Occupants.

The real property and personal property encumbered by the deed of trust will be sold at the sale in accordance with the provisions of the deed of trust and as permitted by section 9.604(a) of the Texas Business and Commerce Code.

6. *Obligations Secured.* The deed of trust provides that it secures the payment of the indebtednesses and obligations therein described (collectively, the "Obligations") including but not limited to the promissory note executed by Billy Ray Leathers and All Occupants, and payable to the order of Olin Elmer Leathers. Olin Elmer Leathers is the current owner and holder of the Obligations and is the beneficiary under the deed of trust.
