NOTICE OF FORECLOSURE SALE

1. Property to Be Sold. The property to be sold is described as follows:

4. Terms of Sale. The sale will be conducted as a public auction to the highest bidder for cash. Pursuant to the deed of trust, the mortgagee has the right to direct the Trustee to sell the property in one or more parcels and/or to sell all or only part of the property.


