

TRACT ONE:

Field notes for the survey of a certain lot, tract, or parcel of land being a part of Lots 9 and 10 of the Woodland Park Subdivision, according to plat recorded in Slide A-217 of the Official Plat Records of Hill County, Texas. Said land is all that certain tract described in a Substitute Trustee's Deed from Martha McGregor to Charlene Cranshaw Whalen recorded in Volume 793, Page 712 of the Official Public Records of Hill County, more particularly described as follows:

BEGINNING at a 5/8" iron rod found in the west line of State Highway 22 for the southeast corner of said Lot 9 and for the southeast corner of this;

THENCE with the south line of said Lot 9 and generally along a fence as extended, N69°36'40"W 139.85 feet to an iron spike found at a metal fence corner for the southeast corner of that certain tract described in a deed to Nicky D. Nix recorded in Volume 923, Page 712 of the Official Public Records of Hill County and for an outside ell corner of this;

THENCE generally along a metal fence, N19°50'31"E 10.94 feet to a 3/8" iron rod found at a fence corner for an outside ell corner of said Nix tract and for an inside ell corner of this;

THENCE generally along a metal fence, N69°33'04"W 59.76 feet to a 1/2" iron rod set at a fence corner for the southwest corner of this;

THENCE generally along a metal fence, N21°09'18"E 187.87 feet to a 1/2" iron pipe found in the north line of said Lot 10 for the northeast corner of said Nix tract and for the northwest corner of this;

THENCE S70°00'17"E 199.34 feet to a 1/2" iron rod set in the west line of State Highway 22 for the northeast corner of said Lot 10 and for the northeast corner of this;

THENCE with the west line of State Highway 22, S21°00'00"W 200.23 feet to the place of beginning, containing 0.899 acres of land.

TRACT TWO:

All that certain lot, tract or parcel of land lying and situated in Hill County, Texas, and being a part of Lot Eleven (11), Woodland Park Subdivision, according to the plat recorded in Volume 162, page 66 of the Hill County Deed Records, being more particularly described by metes and bounds as follows:

BEGINNING at the northeast corner of Lot 11 being the southeast corner of Lot 12;
THENCE — Southward 100 feet with the east line of Lot 11 to the northeast corner of Lot 10;
THENCE — Westward with the common line between Lots 10 and 11, 200 feet to a point for corner and being the northwest corner of a tract deeded from W.G. Brooks et ux to C.G. Murray by a deed recorded in Volume 500, page 443 of the Hill County Deed Records;
THENCE — North 21 East, 100 feet to a point for corner in the common line between Lots 11 and 12;
THENCE — Eastward 200 feet with the common line of Lots 11 and 12 to the Place of Beginning.
