Hill County Lateral Road & Bridge:	0.073603/\$100 of Value


**AND WHEREAS**, the total proposed tax rate for 2014 for all county funds is **0.529977/\$100** of Value,

**AND WHEREAS, THIS TAX RATE IS THE EFFECTIVE TAX RATE FOR ALL FUNDS. THIS TAX RATE WOULD IMPOSE THE SAME TOTAL TAXES AS LAST YEAR IF YOU COMPARE PROPERTIES TAXED IN BOTH YEARS.**
