(CST) at the Hill County Courthouse's area as designated by the Hill County Commissioner's office or as designated by the Hill County Commissioners Court located in Hillsboro, Texas, I, the undersigned, will sell at public auction to the highest bidder for cash the real property described in the Deed of Trust recorded in Volume 2304, Page 819, of the Official Public Records in Hill County, Texas, and all corrections of record thereof (the "Real Property"). The earliest time that the sale will begin is 10:00 A.M.

This sale will be made to satisfy the debt evidenced by the Wraparound Promissory Note dated February 23, 2024, in the original principal sum of \$225,000.00, executed by you as Maker to TXOK Investments, LLC as Payee and secured by and pursuant to the power of sale conferred in the Deed of Trust dated February 23, 2024 (the "Deed of Trust"). The Deed of Trust was executed by you as Grantor to Gary H. Shahan as Trustee for the benefit of TXOK Investments, LLC (the "Beneficiary") and was recorded in Volume 2304, Page 819, of the Official Public Records in Hill County, Texas.

The Beneficiary has appointed and substituted me, the undersigned Nicholas E. Arrott II, as Substitute Trustee under the Deed of Trust by a written Appointment of a Substitute Trustee, which is recorded in the Official Public Records of Hill County, Texas. As Substitute Trustee, I am vested with and succeed to all the powers and duties given to the original Trustee. Thus, the Beneficiary has requested me, the undersigned Substitute Trustee, to enforce this trust by selling the Real Property because you are in default in the payment of the note described in the Deed of Trust.

Your debt has been accelerated, and the entire unpaid balance of your note is now due and payable. You now owe TXOK Investments, LLC the sum of \$239,978.94. 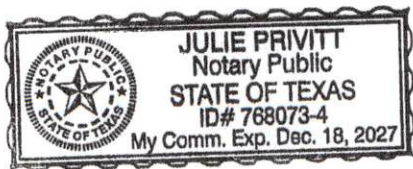
