Tract One field notes for the survey of a certain lot, tract, or parcel of land being all of Lots 7, 8, and 9, Block 7 of the Greenwade Addition to the City of Whitney, Hill County, Texas, according to plat recorded in Volume 100, Page 633 of the Deed Records of Hill County. Said land is all that certain tract described in a deed from Betty Head to Jerry Moffatt recorded in Volume 1968, Page 248 of the Official Public Records of Hill County, more particularly described as follows:

Beginning at a ½" iron rod set in the west line of a 20 foot alley for the southeast corner of said Lot 9 and for the southeast corner of this, said rod being S65°56'40"W 20.05 feet and N28°08'00"W 50.00 feet from a ½" iron rod found at the intersection of the east line of said alley with the north line of Hoover Avenue (South 5th Street) for the southwest corner of Lot 11 of said Block 7;

THENCE S65°54'22"W 114.50 feet to a ½" iron rod set in the east line of South Brazos Street for the southwest corner of said Lot 9 and for the southwest corner of this;

THENCE with the east line of South Brazos Street, N27°44'25"W 150.01 feet to a ½" iron rod set for the north west corner of said Lot 7 and for the northwest corner of this;
