Information Guide

**Adult Probation can help you stay out of jail, continue working, living with your family and fulfilling your goals in life.
 Let us work together to get you through this probation:**

JUDGE HAS SPOKEN

So, you made a mistake - made the wrong decision - and were arrested. The Judge placed you under the supervision of the Hill County Community Supervision and Corrections Department (Adult Probation). If you think being on probation is easy, think again. You will need to comply with some stringent rules and regulations. Depending on your assessment and evaluation you may also need to attend treatment meetings or classes as required by the courts. The big advantage to being on probation is that you are not incarcerated. Instead, you are able to continue working at your job and living at home with your family. If you comply with all the conditions of your probation, you may even be eligible for early release or eligible to have your record sealed. The decision of how you comply with the conditions of your probation will be yours and yours alone. Your probation officer will be available to answer any questions or doubts you may have and to give you the support you may need. You may also consult your attorney if you have additional questions. Always keep in mind that if you do not satisfy all the conditions of your probation, the alternative is that the Judge may need to make a decision that could impact your freedom to come and go as you please. Remember, your probation starts the day you are sentenced.

BASIC CONDITIONS

The judge will impose such conditions on your probation as Indicated by the offense committed and by your life's circumstances. These would include:

- Reporting once a month or as required by your assigned probation officer.
- Refraining from committing any new crimes.
- Abstaining from consuming any alcoholic beverages or other drugs, including any product containing THC.
- Avoiding all visits to bars and night clubs.
- Providing your dependents and family members with the needed economic support.
- Attending court ordered classes, group counseling and drug education programs as ordered.
- Participating in alcohol and drug abuse treatment and rehabilitation programs as ordered.
- Performing community service restitution work at a non-profit organization 501(C)(3) as ordered.
- Paying probation and court fees as ordered.

NEED HELP / HAVE QUESTIONS

Being arrested, going to court and getting sentenced is not something you wanted or needed in your life. Fortunately, you were placed on probation and not sent to prison. Your supervision officer can be very helpful to you. He/she can answer any questions you have, schedule classes or programs and help you set up appointments to fulfill your probation obligations. Your officer will supervise you as directed by the Court and will inform the Court as to how you are abiding by the rules. His/her job is to protect the community by seeing you at home or work as well as in the probation office. Continuous communication between you and your officer is very important.

SETTING GOALS

Now that you're on probation, the first question you have to ask yourself - before asking all those other questions - is what do I really want to do with my life? What is my goal for the future? Do I really want to continue my life reacting to my mistakes, instead of taking control of my actions and avoid repeating the same errors? Remember, the next time you are arrested the judge might not be so lenient. First, write down your goals and make a contract with yourself on the things you want from life now. These could be:

1. **Stop drinking and/or abusing drugs.**
2. **Take better care of your family.**
3. **Take care of your job or find a better job.**
4. **Enlist the positive support of your family.**

TIPS TO COMPLYING WITH PROBATION

Achieving your goals has the advantage that it goes hand-in-hand with complying with your probation. Here are some tips on how to stay in compliance:

1. **Avoid going out with your negative influences.** Peer pressure is difficult to resist, particularly when your friends start teasing you for not drinking. If you are seen in a bar or get stopped for drunk driving, this violates your probation.
2. **Do not fail to report to your probation officer.** Call your probation officer and reschedule your meeting as soon as possible.
3. **Do not commit new crimes.** If you feel you cannot control your drinking, your use of drugs or your temper, talk to your probation officer. Ask for help. Most second, third and following offenses are committed under the influence.
4. **Attend all court ordered programs.** Hill County CSCD offers several programs, including those on alcohol and drug abuse, anger management and cognitive behavior. Take advantage of the services provided to help you.


5. **Perform your community service as ordered by the courts.**
6. **Pay your fines and fees as ordered by the court.**

STANDARD OPERATING PROCEDURES

Entering the office:

- Sign in at the desk.
- Pass thru the metal detector. **DO NOT** bring anything that could be classified as weapon.
- Food and drinks are not allowed.
- Friends, family, children and pets are not allowed.
- Vapes, smoking and or the use of chewing tobacco is not permitted.

Reporting:

- Keep your appointment date and time. It is important to be on time.
- Sign in. Please do not ask the clerk to contact your officer.
- Payments can be made at the desk or by calling 1-800-300-8007 or online at <https://govpay.net/hill-co-probation>. Have your cause number ready.  No personal checks are accepted. **(Note: Convenience fee applies to ALL credit card payments as well as a \$2.00 administrative fee for EVERY payment made).**
- Complete an office visit report at every visit. Bring any required documents such as your check stubs or prescriptions.

Miscellaneous:

- Respect. This is a Probation Office, an extension of the Court. Please turn off you cell phone and use your quiet voice.
- Proper attire is required. You will not be allowed to wear any provocative attire or inappropriate wording or logos.
- Shoes must be worn at all times, please no house shoes.

CIVIL RIGHTS, GUN RIGHTS AND INFORMATION

Being placed on community supervision, pretrial diversion, or bond supervision affects your civil rights and gun rights.

The Right to vote:

- Misdemeanor Supervision - Rights are not affected and may vote.
- Deferred Adjudication Felony Supervision - Rights are not affected and may vote.
- Regular or Shock Felony Supervision - May not vote until he/she is discharged from sentence. Once the term is completed, he/she can immediately register and be eligible to vote in an election.

Right to serve on a jury:

- Misdemeanor Supervision - May serve on a jury.
Exceptions: For a criminal trial, a person who is on supervision for misdemeanor theft (including a deferred adjudication) cannot serve until discharged with rights restored. For a civil trial, a person who is on deferred adjudication (but not regular supervision) for a misdemeanor theft cannot serve.
- Felony Supervision - May not serve on either a criminal or civil jury until he/she is discharge and the court sets aside the accusation and dismisses the charges against the offender.
Exceptions: The following people may never serve on a jury:
 - Person on Felony DWI, Involuntary Manslaughter, or Intoxication Manslaughter supervision.
 - Person on a regular supervision for a state jail felony offense and was placed on community supervision for that offense prior to September 1, 2007.
 - Person on a regular community supervision for a sexual offense listed in Chapter 62 of the Code of Criminal Procedure, or
 - Person was placed on regular community supervision after September 1, 2007 for a 3g offense, may never serve on a jury.

Gun Rights:

Several offenses and or criminal histories automatically prohibit the application, possession or constructive possession (available access) of firearms or ammunition. Should you wish to purchase, carry, or possess a firearm whether in your home, on your person or to go hunting, you should seek advice from your attorney.

Information:

A person placed on a deferred probation has not been found guilty and therefore there is no conviction. DPS will likely always have a record of your arrest. Deferred felony cases can petition the court for non-disclosure after successful completion but must wait 5 years. Some deferred misdemeanor cases can immediately petition the court for non-disclosure after successful completion but there is a list of offenses that must wait 2 years.

If you violate your conditions of probation, a violation report could be prepared by your Officer and submitted to the Courts, a warrant issued and upon arrest, you may be held in the county jail without bond until a hearing is held. If on a misdemeanor or felony deferred case, a bond will be set by the Judge. Once you go to court, you will be expected to answer to those allegations that you may have violated the terms of your community supervision. If proven that you violated your supervision, the probation could be revoked or amended to include, but not limited to, an extension, increased fine, additional classes or programs or jail time as a condition of supervision. You could also be sanctioned to participate in a special program such as Substance Abuse Felony Punishment Facility (SAFPF), Intermediate Sanction Facility (ISF) or one of many other programs offender by Hill County. The Judge, may however decide to revoke your community supervision term and sentence you to serve jail time.

TRANSFER CASES

If your case(s) are transferred and you have not heard from the other county within 60 days notify Hill County immediately. When the transfer is submitted a \$25.00 transfer fee is assessed for each case and is due within 30 days. Once transferred web reporting instructions will be mailed and you are to report monthly unless otherwise specified. Your court assessed fees and probation fees to Hill County are due on the 1st of each month (GovPay 1-800-300-8007 or <https://govpay.net/hill-co-probation>). Any drug testing and/or class fees are due as assessed by the provider. Once accepted you are encouraged to discuss any problems or concerns with your supervising officer. The officer will then forward those concerns to Hill County as deemed necessary.

Classes can be completed immediately, even before you begin reporting in the other county. Note that Drug Offender Education (DOEP), Driving While Intoxicated (DWI) & Driving While Intoxication Intervention (DWII or Repeat Offender) are all State Certified classes. If there are concerns about not taking the right class, email the information to your Caseworker for verification. If court ordered to complete Cognitive Behavioral Training (CBT) please note that the Hill County CSCD offers the Effective Thinking workbook (\$102) in lieu of the CBT class or it's equal. Please contact your Caseworker for more information.

Also be aware that from time to time you may be required to report in person to both counties. If you receive a letter to report in Hill County after being accepted in another county, do not miss the appointment.
