

All that certain lot, tract or parcel of land lying and situated in the I. D. Houston Survey, Abstract No. 392, Hill County, Texas, being a part of Lot Sixteen of the Original Steiner Donation to the City of Hillsboro, Hill County, Texas, and being the same tract of land described in the deed from Lee Roy Sanders and wife to Kathryn A. Walker and Marcia R. King (hereinafter referred to as Walker tract), executed July 26, 1983, recorded in Volume 634, Page 511, Deed Records of Hill County, Texas, and being more particularly described as follows:

BEGINNING at a 1/2 inch iron rod found (control monument) at a corner, being the northeast corner of said Walker tract, the southeast corner of that certain tract of land described in the Quitclaim Deed from Frank W. Simmons and wife, Lillie F. Simmons to Trustees for the General Public of Hillsboro, Hill County, Texas, executed August 22, 1922, recorded in Volume 206, Page 486 of the Deed Records of Hill County, Texas, the northwest corner of that certain tract of land described as 1.04 acres in the deed from David Craig Wilcox to Peggy Yvonne Wilcox, dated October 2003, recorded in Volume 1249, Page 463, Official Public Records of Hill County, Texas, and being the northeast corner of the herein described tract, said corner bears WEST 79.87 feet from a 1/2 inch iron rod found for the northeast corner of said 1.04 acre tract;

THENCE South 00 degrees 59 minutes 23 seconds West along the common line of said Walker tract and said 1.04 acre tract, 149.30 feet to a 1/2 inch iron rod found for a corner, being the southeast corner of said Walker tract, the northeast corner of that certain tract of land described in the deed from William R. Hodgson and wife, Evelyn Hodgson and Freddie S. Robinson to Henry O. Waller and wife, Jimmie Frank Waller, executed February 20, 1957, recorded in Volume 408, Page 240 of the Deed Records of Hill County, Texas;

THENCE WEST along the south line of said Walker tract, 184.40 feet to a 5/8 inch iron rod found at a corner lying in the east right-of-way line of North Pleasant Street, being the southwest corner of said Walker tract, said corner bears 0.3 feet North and 2.1 feet East of a 3/8 inch iron rod found at the northwest corner of said Waller tract, said 5/8 inch iron rod found also bears North 00 degrees 03 minutes 06 seconds East 199.09 feet from a 1/2 inch steel pipe found;

THENCE North 00 degrees 03 minutes 06 seconds East along said east right-of-way line of said Street, 149.28 feet to a 2 inch steel fence post found at a corner, being the northwest corner of said Walker tract;
