

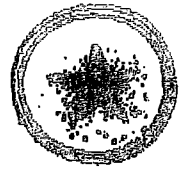

Field notes for the survey of a certain lot, tract, or parcel of land being all of Lots 82, 85, and 86 of the Lakedge Harbor Subdivision in Hill County, Texas, according to plat recorded in Volume 365, Page 331 of the Deed Records of Hill County. Said land is a part of those certain tracts described in a Contract for Deed between Sondra Carter and James and Lisa Baker recorded in Volume 1727, Page 272 and all that certain tract described in a deed from Jerry W. Phillips to CJ & Grace, LLP of the Official Public Records of Hill County, more particularly described as follows:

BEGINNING at a 1/2" iron rod found for the southeast corner of said Lot 85 and for the most southerly southeast corner of this;

THENCE with the south line of said Lot 85, N49°45'12"W 109.65 feet to a 1/2" iron rod found at the end of an old fence for the northwest corner of Lot 79 and for the northeast corner of Lot 78 of said Subdivision;

THENCE N49°50'00"W 98.65 feet to a 1/2" iron rod set in the east line of Ponko Toe (Pontotoe) Trail for the southwest corner of said Lot 85 and for the southwest corner of this;

THENCE with the east line of Ponko Toe Trail, N02°54'50"E 129.29 feet to a 1/2" iron rod set for the northwest corner of said Lot 85 and for the southwest corner of said Lot 86 and N12°29'30"E 114.86 feet to a 1/2" iron rod set for the northwest corner of said Lot 86 and for the northwest corner of this;

THENCE S50°12'50"E 161.19 feet to a 1/2" iron rod found at a chain link fence corner for the northeast corner of said Lot 86 and for the northwest corner of said Lot 82;

THENCE S48°53'41"E 172.72 feet to a 3/8" iron rod found in the west line of Deep Canyon Drive for the northeast corner of said Lot 82 and for the northeast corner of this;

THENCE with the west line of Deep Canyon Drive, S10°30'30"E 157.74 feet to a 1/2" iron rod set for the southeast corner of said Lot 82 and for the most easterly southeast corner of this;

THENCE N49°50'00"W 221.55 feet to a 1/2" iron rod set for the southwest corner of said Lot 82, for the southeast corner of said Lot 86, for the northeast corner of said Lot 85, and for an inside ell corner of this;
